6. **First born child:** Affidavit on a non-judicial stamp paper of Rs.10/-, to be signed by both parents (Deponent 1, Deponent 2)

7. **School alumni:** Class XII School leaving certificate/mark sheet of the alumni parent of any school under the aegis of Salwan Education Trust.
8. **Girl Child:** Birth Certificate of the child issued by MCD or a competent authority.
